Enrollment Information

Sibling Discount:

A 10% discount will be given on equal or lesser sibling tuition.

Tuition Discount:

A 5% discount will be applied for full-year payment of tuition by August 15, 2024.

Registration Fee: A \$70.00 non-refundable registration fee is due upon registration.

All families who register by January 31, 2024 will be entered in a drawing. Two winners will be chosen and will have their \$70 registration fee credited towards their September 2024 tuition payment.

Activity Fee: A \$80.00 Activity Fee is due with September's tuition.

Preschool Tuition for May 2025 is due upon registration.

If unable to pay in full at the time of registration, you may pay in 5 installments (January-May). This will be fully credited to the account to cover the last payment of the school year in May 2025. This is non-refundable unless you move out of our area prior to June 30, 2024. In this case, a 50% refund of May 2025's tuition will be sent to your new address. After moving, you may request the refund in writing. No refunds will be issued after June 30, 2024.

Tuition Payments:

Preschool and Extended Care children are accepted according to a specific number of budgeted spaces in our program. **By enrolling your child in the program at Chester Bethel, you are committing to monthly payments for the duration of the school year (September-May).** *Rates are calculated based on the number of days in the school year and divided into 9 monthly installments.* **Refunds** are not issued for absences, weather-related closings or holidays. A thirty-day notice must be provided if a child is **withdrawn** from the program, and the May 2025 tuition payment will be forfeited.

Late Fees:

Monthly tuition is due the first school day of each month. Payments received after the 5th of the month will incur a \$10.00 late fee. Payments received after the 10th of the month will incur an additional \$10.00 late fee. A \$25.00 fee will be charged for all returned checks. If monthly tuition payments become one month delinquent, the Preschool Board of Directors reserves the right to exclude the child from school and forfeiture of enrollment may result.

Financial Assistance:

Financial Aid may be requested. Applicants must provide 2 current pay stubs, their most current W-2 statements, and a description of their financial situation. The Chester Bethel Preschool Board and Chester Bethel United Methodist Church will review applications, and financial aid will be awarded based on available funds.

Purchase of Care:

We accept Purchase of Care through the State of Delaware. Purchase of Care students are accepted according to a specific number of budgeted spaces in our program.
